ABOUNA'S REFLECTIONS

She,³ therefore, reaches mightily from one end to the other, and she orders all things sweetly, exceedingly well.⁴

All praise be to the Good One for His generosity, Who continually bears us up by tender mercy in the workings of His order and wisdom. We move forward.

We all love the building and grounds of our parish, and we all desire to see her community thrive in all things: both spiritual and material.

Diligently over the last three months, the Finance Committee has contacted the companies that have been asked to put out bids for the work. The new quotes, as of last week, have finally come in. These construction estimates were made last Spring, but as we had not matched the Challenge Grant we could not proceed and these estimates needed to be updated for consideration this year.

It is important to understand the eparchial directives for projects such as these. There seem to be some parishioners who think this is a matter of "fiat", simply saying "yes" and plowing ahead. This is not true. It is not that simple, nor do things happen overnight. We work as we must – with order and with prudential foresight.

You know (this), my dearest brethren; and let each be swift to hear, but slow to speak, and slow to anger.⁵

As disciples of the Word Son – eternal Word of the hidden and silent Father – each of us needs to consciously work to *listen more, speak less*, and be *even slower to judge*. Rash judgement causes the destruction of families and the death of communities. Let us never be the culprit in generating fruitless "chatter" on social media. These agitations do not accomplish the will of God.

Impatience solves no problems, and frustration hurries along no projects. Anger and fury *accomplish* even less; while, it must be said, gossip and a critical spirit are positively corrupting. These aggressive attitudes do not achieve, nor fulfill the purpose of God's Plan and they do not manifest the work of the Good One: "the anger of man does not produce the righteousness of God".6

There has ever been order and reason in all the workings of Holy Mother Church, and there are obligatory procedures in the manner that we must proceed in the eparchy. Our eparchy requires all projects that exceed \$10,000.00 to be submitted for prior approval.

When a project is proposed to the eparchy there must be *at least three* estimates included. Two years ago, in the fall of 2020, I did ask the bishop to be allowed to begin the masonry work, and the request was denied. The request was refused (based as it was on but a single estimate submitted) and the eparchial directives were reiterated.

Once updated estimates have been gathered, and the funds for the projects are verifiable, the Finance Council and the Pastor write up a *votum*, that is, the desired proposal that is presented to the bishop and the eparchial offices along with the estimates. This, once approved, allows a parish to proceed with its major projects.

"Verifiable funds" must also be shown in order to proceed on such projects. As all well know, the parish has not met its annual budget for many, many years now (this was the primary reason to establish an endowment fund in 2015) and our proposal needs to show to the bishop that we can pay for such a large project.

The Eparchy does not subsidize parishes – the parishes subsidize the eparchy.

As you know from the published financial report, our Endowment Fund reached \$600,000.00 at the end of December 2021. However, from that date onward the financial markets have dropped precipitously and our invested funds have *lost* \$55,000.00 (this is equal to almost the entire amount needed for our masonry maintenance!). Matching our Challenge Grant will merely plug this dramatic financial hole.

We struggle, but we do so with hope and confidence.

Although it is true that the *poverty syndrome* means that works that are put off for lack of funds increase in expense as time goes on, we must be realistic in estimating our capabilities. We cannot/will not go below the level of our endowment capital (\$500,000.00), this would defeat the purpose of setting it up. The Endowment is not simply another bank account from which to pull funds. Over the last twenty years all extraneous bank accounts have already been drained in such a manner.

An endowment fund is meant to generate supplemental income, which does not look to happen this year. In any case, a \$500,000.00 invested endowment might be expected to generate around \$25,000.00 – in a good year for the markets, which this one is certainly not – but this sum is only slightly half of our average annual deficit.

It's math; either regular contributions must increase or the *fundraisers* will have to fill up the additional \$25,000.00.

Clarity of thought must take priority, and clear goals must be set for the future to be sustained.

Be silent in the presence of the LORD, and wait patiently for him to act.7

These are, therefore, the minimal things we must do to go forward. The Finance Council is aware of this, and is proceeding accordingly.

To note:

- 1.) the **construction estimates** the minimal *three* to be submitted as of last week have been updated and made current for this year.
- 2.) the *votum* is being drawn-up by the Pastor and the Finance Council that will be submitted to the bishop's final decision and approval.
- 3.) when all the above is in hand, *then* the project can be **scheduled** with the chosen company in order to move forward.

All those who have contributed to these projects are to be heartily thanked. Those who have exercised wisdom in patience and charity are to be commended, and those who patiently cherish hopes for a grace-filled future will be consoled in the workings of the God of mercies. Wisdom labors strongly, sweetly, touching all things, and she manifests the charity and calm of the Good One. We should all act likewise.

During these last couple years of pandemic, trial, disappointment, and hardship, your generosity has done wonders to improve our financial footing, expand our apostolic reach, and continually encourage us to turn our eyes with hope toward a bright future.

The consoling grace of God comes to those who labor patiently under the Cross, who live with charity filling their souls, who are gentle in spirit, peaceable and not rash in judgement, and who follow in the footsteps of the Sacred Heart.

This most do beautifully.

The Assumption of the Ever-Virgin Mary into Heaven, body and soul (August 15th)


As we were reminded by our Patriarch in his encyclical, it is our tradition to fast in preparation for the great feasts, and all are encouraged to do so faithfully, *par*. 24:

This fast is known as "The Fast of the Virgin", during which the faithful abstain from eating meat, dairy products, and eggs, from August 7th until August 14th inclusively.

We are also reminded in *paragraph* 21 of the same letter that "a fast" is to go without all foods *from midnight to noon*, after which we *abstain from all animal flesh and most all animal products* – this is most similar, but not exactly the same, to a "vegan" diet.

When a fast day falls on a Saturday or a Sunday (as will be the case on August 7th, 13th and 14th this year) one can eat as they wish, but should still abstain from animal flesh, dairy, and animal products, although shellfish is permitted.

These observances are for all who have attained the age of the use of reason, *par*. 22
